Tax payments in 4 installments

If the total sum of the general taxes, other taxes, tariffs and compensations exceeds \$300, these taxes are payable in 4 installments, on:

- 1st installment:** March 1st 2017
- 2nd installment:** May 1st 2017
- 3rd installment:** July 3rd 2017
- 4th installment:** September 1st 2017
